The Easter Egg Hunt was a big hit. 55 Children and 30 adults attended. Upcoming programs include adult trivia, and an interactive mystery event. She showed several examples of art projects for the children that Cathy Spencer will lead during the summer reading program. She asked membership to bring toilet paper rolls in for that purpose.

Art Fair: Mary Lou Jennette made a motion to approve \$25.00 for our space at the Roscommon Art Fair as part of outreach. Erin Layton seconded the motion. Motion carried.

Sign up sheets were circulated for volunteers for Summer Reading, Business Expo and the Art Fair. We got several volunteers and sheets can go around again next month.

We took a few minutes to review our “just for fun” activities from the winter. Everyone seemed to have a good time and decided we should do something similar next year.
