Linda Brick reported that good books have been donated, and sorting will begin in the basement after the meeting. Pre-sorting makes setting up for sale much easier. We have a nice selection of books at this time.

Beth Myers, and Allison March reported on their research for ordering book bags for the library. They checked with several local businesses and had samples to show. Prices have increased since our last purchase years ago. Discussed if this was to be used as a fund raiser or will it be available for patrons to purchase for what we pay for them. Beth and Allison will work with Cora to design a logo, and decide a good color, and they will check a few other places. More information at next months meeting.

Dorothy Backus reminded us of her cut-out craft day on May 20, 2026. An email will be sent with information about supplies needed.

Library Director's Report: Colleen is on vacation this week, the group went over her report of upcoming events.

Linda Brick said there is a sign being made telling days of book donations that will be displayed in front of library.

Julie McNaughton asked how our budget was set up. Lisa went over the FOL budget procedure. Our goal is to help the library needs whenever we can.
